GENERAL

- 1.1. We reserve the right to amend, vary or cancel these terms and conditions at any time.
- 1.2. By booking an appointment with us, you are subject to these terms and conditions.
- 1.3. No photographs or videos may be taken on the premises at any time without our written permission.
- 1.4. All attendees under 21 years of age must be accompanied by their parent or legal guardian at all times.

IMAGES - All image sizes are nominal. The photographer will provide a pleasing colour balance but cannot guarantee exact colour matching owing to anomalous reflectance caused by a combination of certain dyes and materials especially man-made fibres. It is sometimes impossible to record on film the exact colour as seen by the human eye.

RE-TOUCHING - The Services shall include the retouching of images at the Photographer's sole discretion. Any editing or retouching requested by the Client will be subject to the Photographer's hourly rate of £50

NEGATIVES/DIGITAL FILES - Negatives/digital (RAW) files remain the property of the photographer and will, under no circumstances be relinquished.

COPYRIGHT - Any images or copies of images whether stored digitally or otherwise and any computer program including any source or object code, computer files or printed documentation relating to such images are protected by the Copyright and Design Act 1988. It is contrary to the Act to copy or allow to be copied photographically/ electronically or by any other means an image created as part of this contract without the permission of the photographer and must never be used in any commercial capacity without the written consent of the photographer. Any breaking of seals in the viewing album will presume a breach of copyright.

LICENSE - The photographer shall be granted complete artistic license including in relation to the poses photographed and the locations used. The photographer's judgement regarding the location/poses, number of images taken and album design shall be final. Due to the vagaries of the weather and the willingness of subjects it may not be possible to capture all the images requested.

FORCE MAJEURE OR ACT OF GOD - The due performance of this contract is subject to alteration or cancellation by either party owing to any cause beyond their control.

DISPLAY - The client hereby allows the photographer to display any images included in this contract in their studios, portfolios, literature, wedding exhibitions, advertising and websites. No use of the images will be made by the photographer for other commercial reason except with the written permission of the client.

CANCELLATION - The client may cancel this contract at any time by giving written notice to the photographer but in doing so may forfeit any costs and monies paid.

LIMIT OF LIABILITY - In the unlikely event of a total photographic failure or cancellation of this contract by either party or in any other circumstance the liability of one party to the other shall be limited to the total value of the contract. Neither party shall be liable for indirect or consequential loss.

COMPLAINTS - Any complaints must be raised by the client with the photographer in writing within 28 days of first becoming aware of the matter to be complained of and in any event within 28 days of receipt of images.

EXCLUSIVITY - Mobile phone or any other media device is not allowed in the studio or on location of the shoot. No photos are allowed to be taken other than that of the photographer. The client agrees that Gail Bassett shall be the exclusive paid professional photographer retained by the client for the purposes of photographing the wedding/photo shoot on the date shown above.
